**CAPTAIN OF THE PORT SHIPMENT NOTIFICATION REQUIREMENTS**

1. The following Hazard Classes must be accompanied with properly completed shipping papers when the shipping notification is made. Notification requirements are found in 33 C.F.R. 126.27(b) and 49 C.F.R. 176.415
  - a. Any amount of Class 1.3 & 1.5 EXPLOSIVES in excess of 40 net tons.
  - b. All Class 2.1 in bulk packaging or in excess of 80 net tons at any one time.
  - c. All 2.3 POISON GAS in excess of 80 net tons at any one time.
  - d. All Class 4.1 FLAMMABLE SOLIDS or Class 5.1 OXIDIZERS in excess of 100 net tons at any one time.
  - e. Flammable gases (not in bulk) , in excess of 10 net tons at any one time.
  - f. Any amount of a cargo of particular hazard, as defined in 33 CFR 126.10(d).

THE CAPTAIN OF THE PORT MIAMI ZONE DOES NOT ALLOW ANY CLASS 1.1. 1.2 EXPLOSIVES AND CLASS 7 RADIOACTIVE MATERIALS TO ENTER INTO THE C.O.T.P. ZONE (PORT OF PLAM BEACH, PORT EVERGLADES, PORT OF MAIMI).

2. NOTIFICATION WITHOUT PROPERLY PREPARED SHIPPING PAPERS WILL NOT BE APPROVED FOR HANDLING, STORAGE, STOWING, LOADING, DISCHARGING, OR TRANSPORTING WITHIN THE CAPTAIN OF THE PORT MIAMI ZONE. ALL ITEMS ON THIS SHEET MUST BE KNOWN PRIOR TO SUBMISSION TO C.O.T.P.
3. SHIPPING DESCRIPTION WILL BE OBTAINED FROM 49 C.F.R., 1.M.D.G. CODE UNLESS AUTHORIZED FOR ANOTHER MODE OF SHIPMENT.
